Notice 1 告示 1

This show flat is for showing the residential property concerned only and does not constitute and shall not be construed as constituting any representation or warranty in respect of the view from any residential property in the Development or the external appearance of any part of the Development, whether or not the external finishes, external pipes, or appearance of any part of the Development have been shown.

There is slight difference in dimensions of this show flat and of the bay window, utility platform and balcony from those as specified in the sales brochure, and the difference is due to the finishes on the enclosing walls or boundary walls or internal partitions of the unmodified show flat.

The air grilles, fire sprinklers, visual advisory alarms, emergency lighting sprinkler heads, exit signs, speakers and features marked with green dots “●” in this show flat are the in-situ built-in facilities of this venue. There are no such facilities in the residential properties of the Development and it may not be possible to install such facilities in the actual property. For fittings, finishes and appliances of the residential properties in the Development, please refer to the sales brochure.

The floor-to-ceiling height of different parts of this show flat is less than the corresponding projected height of the parts concerned of the residential property as specified in the sales brochure by the relevant difference as set out in the plan below due to physical constraints of the venue. Due to the finishes on the floor and ceiling of this show flat, it is possible that there will be a difference between the floor-to-ceiling height of the show flat obtained by taking measurements inside the show flat (it will not be able to take into account of the thickness of the aforesaid finishes when taking such measurements) and the projected height (less the aforesaid height difference) of the corresponding residential property. Please see the below ceiling plan for the extent of lower ceiling height area.

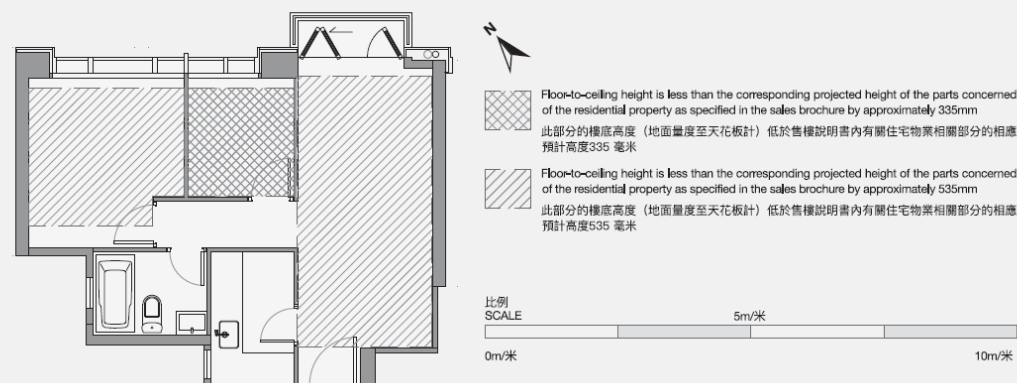

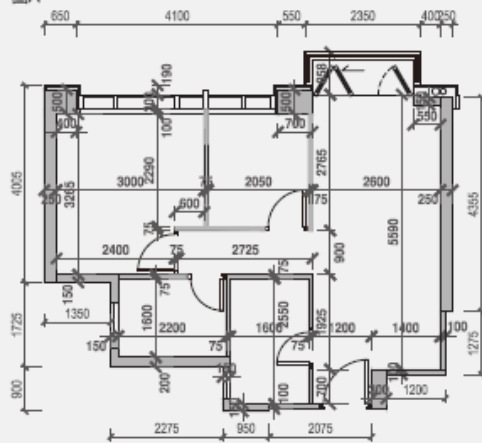
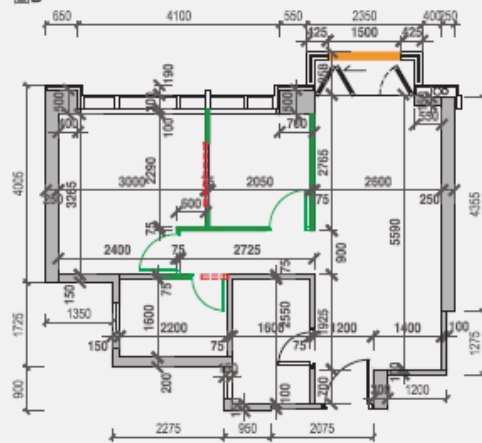

The passageway exit as shown in Diagram B in orange (■) is provided as a means of escape for the purposes of regulation 41(1) of the Building (Planning) Regulations (Cap.123 sub. leg. F) and there will be no such passageway in the actual unit upon handover.
 2. Please refer to the Sales Brochure for the details of the floor plan of the unit.

The internal partition and doors in the residential property which would exist in the actual unit as depicted in the Sales Brochure marked in green solid lines (—) in Diagram B are not provided in the show flat. The position and thickness of such internal partitions are marked by chrome metal solid lines on the floor. The internal partitions marked in red dotted lines (---) in Diagram B are additional internal partitions of the show flat. By virtue of Section 41 (3) of the Buildings Ordinance (Cap. 123), the internal partition and doors marked in green solid lines may be removed from the unit without the approval of the Building Authority. Please refer to the Sales Brochure for details of the unit layout plan. Should purchasers remove or alter or add any internal partition(s) or door(s) or make alterations to the layout design and/or fittings of the unit, they should comply with the Buildings Ordinance and other ordinances and regulations as well as the provisions in the Land Grant and Deed of Mutual Covenant, or obtain the required consent or approval from the relevant competent authority or the manager of the Development.
